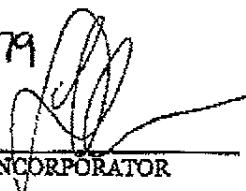
ELEVENTH: The corporate existence of the Corporation shall commence on the date of filing with the Secretary of State.
