**CHANGE OF DIRECTORS/OFFICERS:**

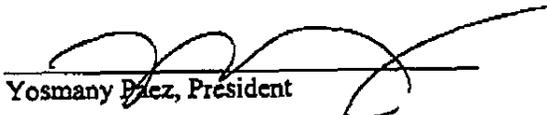
Joel Urfa is hereby deleted as Vice President of the Corporation.

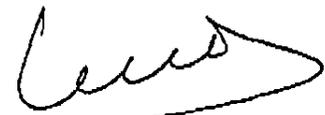
