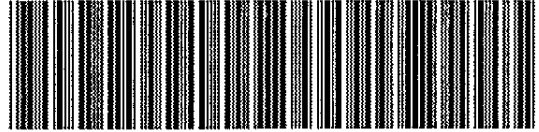



ARTICLES OF INCORPORATION  
OF

I, the undersigned do hereby form a corporation for the purpose hereinafter stated and do hereby certify as follows:

ARTICLE I - NAME

The name of the corporation shall be and is hereby declared to be LANCER LOGISTICS, INC.

ARTICLE II - PRINCIPAL OFFICE



