**ARTICLE I  
NAME**

The name of this Corporation is **PAN AMERICAN MANAGEMENT, INC.**, and its mailing address is 150 Alhambra Circle, Suite 925, Coral Gables, Florida 33134.

This Corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act, as amended from time to time.



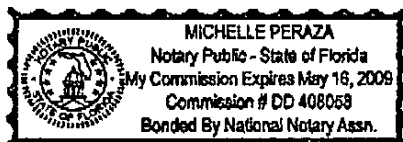


