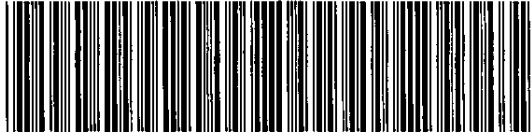

SHARES

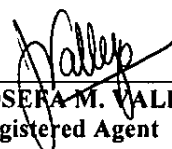
