**Article I - Name**

The name of this corporation is Pro-Tech Supply Company.

**Article II - Purpose**

This corporation is organized for the purpose of transacting any lawful business.

**Article III - Capital Stock**

The aggregate number of shares which this corporation shall have authority to issue is 1000 shares of common stock consisting of one class and having a par value of \$1.00.

**Article IV - Preemptive Right**
