## ARTICLES OF INCORPORATION OF RICHARD A CURTIS, P.A.

SECRETARY OF STATE TALLAHASSEE. FLORIDA

#### ARTICLE I

Name. The name of this corporation is RICHARD A CURTIS, P.A.

#### ARTICLE II

<u>Duration</u>. The corporation shall be perpetual.

#### ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting real estate brokerage and sales business.

#### ARTICLE IV
