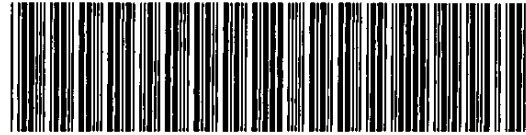

The undersigned acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE II

This corporation may, and is authorized, to engage in the sale of real estate as permitted under the laws of the United States and of the State of Florida.

The power to adopt, alter, amend, or repeal By-Laws of this corporation shall be vested in the Board of Directors and the Shareholders.



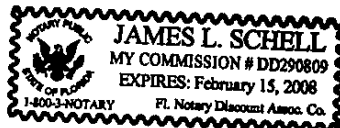
