ARTICLES OF INCORPORATION

OF

ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **FRONT PORCH DESIGNS INC.** and the principle place of business of this corporation shall be: 5590 12TH Street South, St Petersburg, FL 33705-5054.

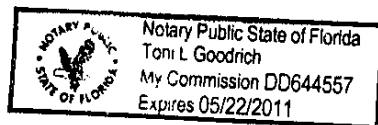
