ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act hereby associate themselves together to form a corporation for profit and adopt the following Articles of Incorporation for such corporation.

ARTICLE I: Name

The name of this corporation is: Courtade Investments, Inc.

The period of its duration is perpetual unless dissolved by action of law.

The purpose is to engage in any activity or business permitted under the laws of the State of Florida.
