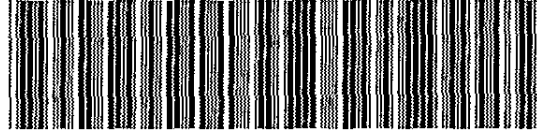

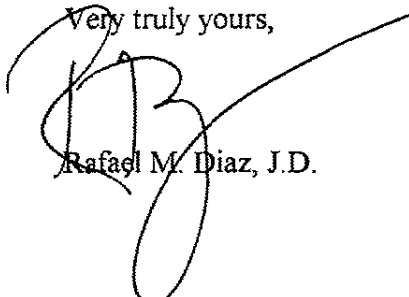

**ARTICLES OF INCORPORATION
OF
LATIN AMERICAN LEGAL SUPPORT SERVICES, INC.**

THE UNDERSIGNED incorporator, for the purpose of forming a corporation in compliance with Chapter 607 and/or 621, F.S. (Profit), hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: LATIN AMERICAN LEGAL SUPPORT SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE

2328 10th Avenue North Suite 600, Lake Worth, Florida 33461

ARTICLE III. PURPOSE

The general purpose of this corporation is to engage in every aspect of the business of rendering the same professional services to the public that an attorney, duly licensed under the laws of the State of Florida, is authorized to render.

ARTICLE IV. SHARES

The aggregate number of shares which this Corporation shall have authority to issue is 7,500 shares of common voting stock at \$1.00 par value per share. 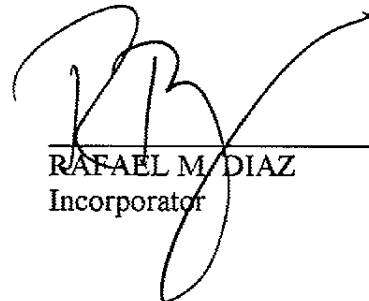
