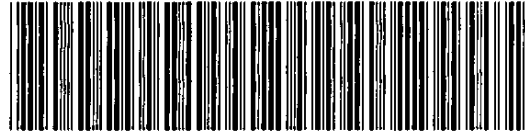

The undersigned natural person, having the capacity to contract and acting as the incorporator of a corporation under Florida Statute Chapter 621, adopts the following charter for such corporation:

ARTICLE I

The name of the corporation is: Peppers 3, Inc.

ARTICLE II

ARTICLE VIII


The corporation is a for profit corporation.
