The undersigned, pursuant to the provisions of Chapters 607 and 621 of the Florida Statutes, for the purpose of forming a corporation under the laws of the State of Florida set forth the following:

ARTICLE I - NAME AND BUSINESS ADDRESS

The Corporation shall have a perpetual existence.
