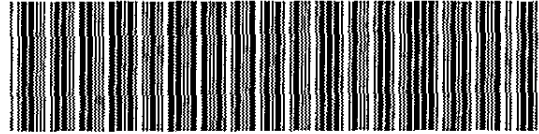

ARTICLES OF INCORPORATION
OF

ARTICLE I NAME

The name of this corporation is Vocational Education Career Leadership Academy, Inc.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing the date of this filing of these Articles with the Department of State.

ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as an educational consulting firm, including but not limited to: teaching, vocational education, youth ministering "at risk" children, preparation/counseling of life skills, focusing on the employability of youth and youth leadership. 




