# ARTICLES OF INCORPORATION of TOPKRAFT COUNTERTOP RENOVATION & DESIGN, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation, which shall hereinafter be referred to as the "Corporation" shall be: **TOPKRAFT COUNTERTOP RENOVATION & DESIGN, INC.**

#### **ARTICLE XI**

Unless otherwise provided in the Bylaws, every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The Bylaws may provide that every stockholder is not to have the right to so purchase. The Bylaws may provide for cumulative voting for Directors and may make provisions governing the issuance of stock certificates to replace lost or destroyed certificates. 
