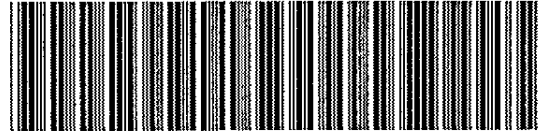



ARTICLES OF INCORPORATION
OF
CWI-CONSTRUCTION WELDING INSPECTIONS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is **CWI-CONSTRUCTION WELDING INSPECTIONS, INC.**

DURATION

The term of duration of the corporation is perpetual.

PURPOSE

The name and address of the incorporator is Paul J. Burns, 12525-Walsingham Road, Largo, Florida 33774.


**ARTICLE NINE




