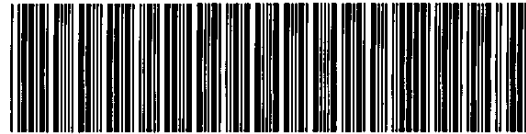

**ARTICLES OF INCORPORATION
OF**

ARTICLE I

The name of the corporation Frizzie Froggies, Inc.

ARTICLE II

The existence of the corporation shall have a perpetual existence, commencing on August 1, 2007.

ARTICLE III

This corporation is organized for the purpose of conducting any or all other lawful business.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 7500 shares of Common Stock. There shall be only one class of stock.

ARTICLE V

The initial street address of the Corporation's registered office is 2129 Crosby Road, Valrico, Florida 33594, and the initial registered agent for the Corporation at that address is David K. Storms.

ARTICLE VI

The initial board of directors shall initially consist of 2 members. The number of directors may be either increased or diminished from time to time as provided for in the bylaws, but shall never be less than one. The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE IX

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which s/he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional Stock) at the price at which it is offered to others.

ARTICLE X

The power to adopt, alter, amend, or repeal these articles or the bylaws shall be vested in the Board of Directors and the Shareholders. Every Amendment must be first approved by Board of Directors, then proposed by the Board of Directors to the Shareholders, and approved at a Shareholder's meeting by a majority of the stock entitled to vote thereon, unless all Directors and all the Shareholders sign a written statement manifesting their intention that a certain Amendment of the bylaws be made.
