The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Gretchen Walker, P.A. Principal place of business is 7401 Wiles Road, Suite 138, Coral Springs, FL 33067.
