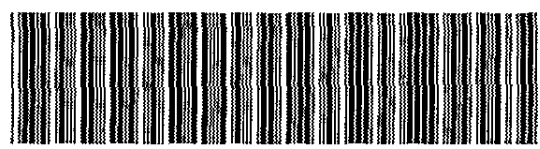

Articles of Incorporation of

The Innovative Market Place Inc.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act does hereby the following Articles Of Corporation.

Article One

The name of the corporation is **The Innovative Market Place Inc.,**

Article Two

The duration of the Corporation is perpetual.

Article Three

The general purposes for which the Corporation is organized are:

1. Property management including management and ownership of real and personal property for businesses and residences, corporations and individuals. Consulting on financial services, and providing insurance services.
2. To conduct its business, caring on its operations and have offices and exercise the powers granted by this act or without this State. To transact any other lawful business for which the corporation may be incorporated under the Florida General Corporation Act or o r engage in any other trade or business which may be in the connection with or auxiliary to the foregoing business.

The aggregate number of shares which the Corporation is authorized to issue is seven thousand five hundred (7,500). Such shares shall be of single class and shall have par value of one dollar.

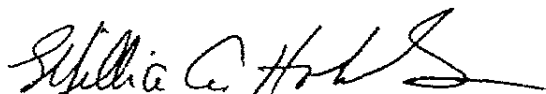
