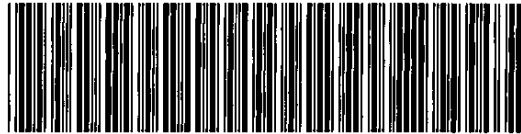

INDEMNIFICATION

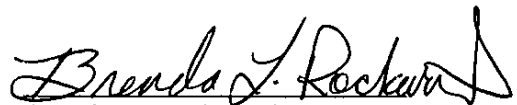

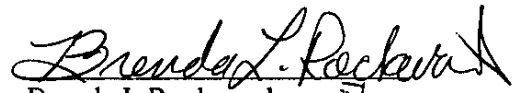

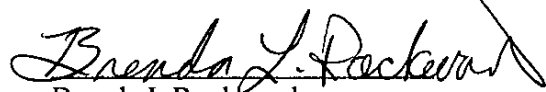
