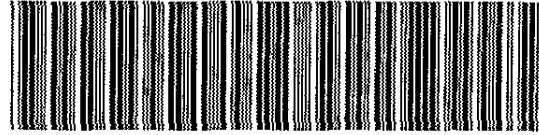

ARTICLE VII - NATURE OF BUSINESS


This corporation may engage or transact in all lawful activities related to architectural services or business permitted under the laws of the United States, The State of Florida or any other state, country, territory or nation.


