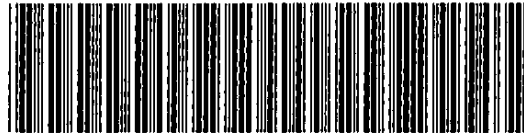

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

These Articles of Incorporation may be amended in the manner provided by law .

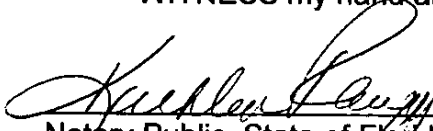
