ARTICLES OF INCORPORATION

OF

MAGNOLIA RC, INC.

ARTICLE 1 - NAME

The name of this corporation shall be:

MAGNOLIA RC, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be: any and all activities permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK




