ARTICLES OF INCORPORATION

The undersigned acting as incorporator of Cantrell Management Services, Inc. desiring to form a corporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Cantrell Management Services, Inc. (the "Corporation").
