# ARTICLES OF INCORPORATION OF MERCURY JET CHARTER, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation is Mercury Jet Charter, Inc. (the "Corporation").

### ARTICLE IJ PRINCIPAL OFFICE AND MAILING ADDRESS
