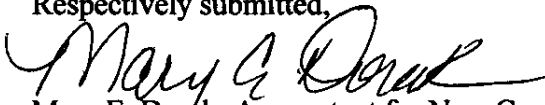

Articles of Incorporation of:

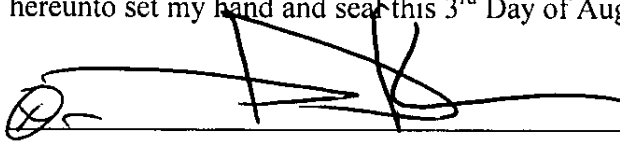

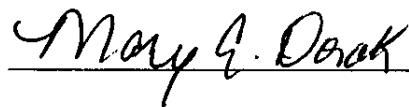

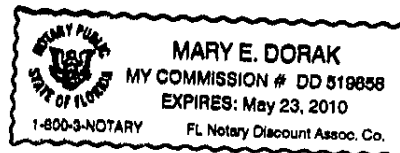
