

### ARTICLES OF INCORPORATION

The undersigned, desiring to form themselves into a corporation under the laws of the State of Florida, do hereby certify as follows:

### **FIRST**

The name of the said corporation shall be " The Lucky Dollar, Inc."

### **SECOND**

The object for which said corporation is formed to do and perform any and all things hereinafter set forth to the extent that natural persons might or could do, viz:

To purchase, to receive by way of gift, subscribe for, invest in, and in all other ways acquire import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign and in all other way. Dispose of. Design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plat, cultivate, produce, market, and in all other ways, deal in and with property of every kind and character, real, personal and mixed, tangible or intangible, wherever situated and however held, including, but not limited to, money credits, cases in action, securities, stocks, bonds, warrants, scripts, certificates, debentures, mortgages, notes, commercial paper and other obligations and evidences of notes, franchises, subsidies, charters, concessions, grants, rights, and immunities of individual owners or holders thereof.

To hire, and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining agreements, and to act and arrangement of every kind and character with any person, firm, association or corporation, or any government or authority or subdivision or agency thereof.

To carry on any business whatsoever that this Corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise or that it may deem calculated, directly or all things specified in the General corporation Laws of the State of Florida, and to have and to exercise all powers conferred by the laws of the State of Florida on corporations formed under the laws pursuant to which and under which this Corporation is formed.

### THIRD

The location and principal place of business of the Corporation shall be 401 Barton Blvd Rockledge, Fl. 32955.

## **FOURTH**

The amount of the authorized capital stock of said corporation shall be One THOUSAND DOLLARS (\$1,000.00), which shall be divided into
