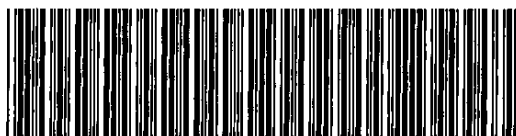

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I: NAME**

**ARTICLE II: PRINCIPAL OFFICE**

**ARTICLE III: EXISTENCE AND DURATION**

This corporation shall exist perpetually commencing on August 03, 2007.

**ARTICLE IV: PURPOSE**
