The undersigned, acting as incorporator of the captioned professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this professional corporation is The Law Office of Robert T. McCabe, P.A., and its principal office and mailing address is 902 N. Armenia Ave., Tampa, FL 33609.

ARTICLE II

Commencement of Corporate Existence

The professional corporation shall come into existence on the date of filing with the Florida Secretary of State.

By-Laws


