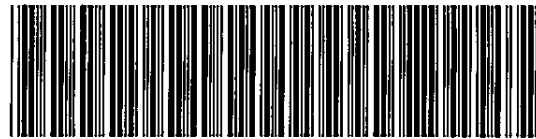

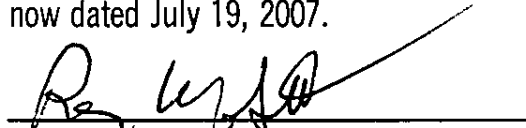

1. Introduction. Roy W. Scott, being duly sworn, deposes and says:

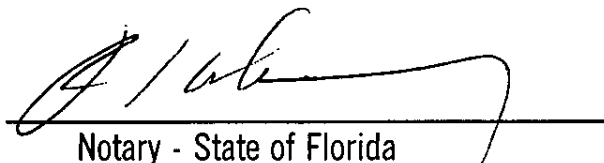

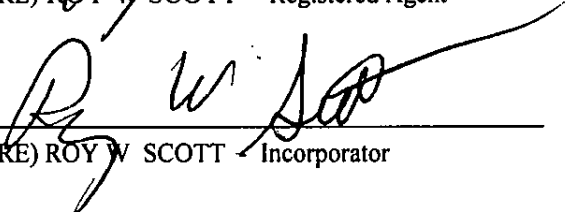
