ARTICLES OF INCORPORATION

OF

LIMITLESS ENTERPRISES, INC.

The undersigned subscribers to these Articles of Incorporation make, subscribe, and acknowledge the following Articles of Incorporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation shall be:

LIMITLESS ENTERPRISES, INC.

ARTICLE II.

The corporation shall have a perpetual existence.

ARTICLE III.

The general nature of the business to be transacted by this corporation shall be:

- i. To engage in every phase and aspect of business that a corporation under the laws of the State of Florida, is authorized to render.
- ii. To invest the funds of this corporation in real estate, mortgages, stocks, bonds, or any other type of investments, and to own real and personal property necessary for the operation of such corporation.
- iii. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this corporation; and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objects of this corporation.
