WAIVE THE FLORIDA DEPARTMENT OF STATE  
CORPORATE REINSTATEMENT FEES**

1. Richard Lemery is the President of RJ LEMERY PHOTOGRAPHY, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation failed to file its 2008 Annual Report or pay the 2008 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
