# ARTICLES OF INCORPORATION FOR AMERIBRIDGE, INC.

In compliance with Chapter 607 of the Florida Statutes, the undersigned Incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

#### Article I

The name of the corporation shall be AMERIBRIDGE, Inc.

Such request shall state the purpose or purposes of the

proposed meeting. Business transacted at any special meeting shall be limited to matters relating to the purpose or purposes stated in the notice of meeting.

To the fullest extent permitted by these Articles of Incorporation and applicable law, the corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he is or was director, officer, employee or agent of the corporation (including its employee benefit plans), against expenses (including attorneys fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him in connection with such action, suit or proceeding if he acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interest of the corporation, and with respect to any criminal action proceedings, had no reasonable cause to believe his conduct was unlawful.
