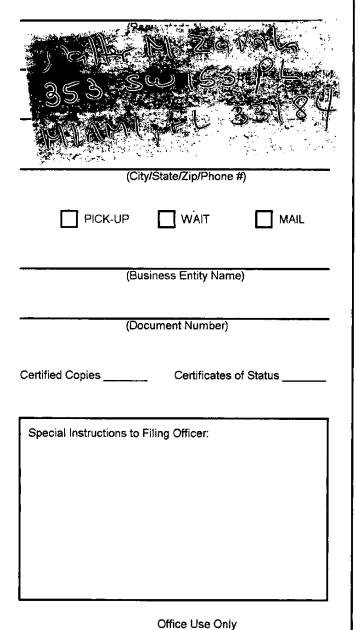

Any director or office who is involved in litigation or other proceeding by reason or her position as a director or office of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.
