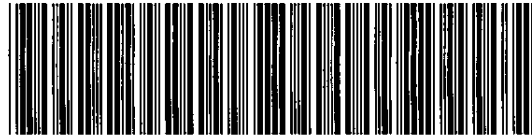

ARTICLE I

CORPORATE NAME

DURATION

This Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

PURPOSE

BY-LAWS

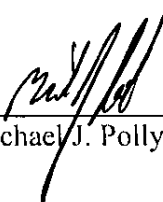

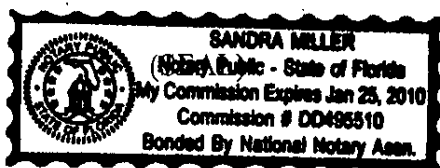

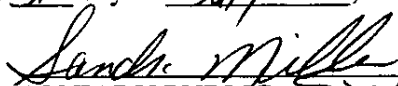
