ARTICLES OF INCORPORATION  
OF  
IMED DATA, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I  
NAME

The name of the Corporation is IMED DATA, INC.

ARTICLE II  
DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III  
NATURE OF BUSINESS

The nature of the business to be conducted by the Corporation is:

1. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act;
2. To develop and sell medical office software for back office and patient medical records; and
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.


