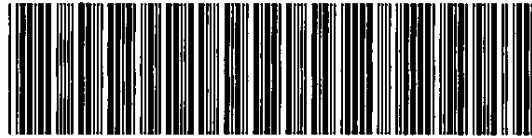

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is JLU YACHT DETAIL, INC., and its principal place of business shall be located at 4579 SE MURRAY COVE CIRCLE, STUART, FLORIDA, 34997 and whose mailing address is P.O. Box 1436, Port Salerno, Florida 34992.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited to boat/yacht detailing.

### ARTICLE X - INDEMNIFICATION






