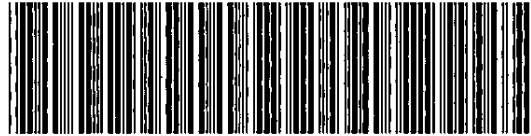

Article I

*Name.* The name of this Corporation is Matcoman, Inc.

Article II

*Principal Office.* The address of the principal office of the Corporation is 7814 SW 52 Place, Gainesville, FL 32608.

Article III

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV
