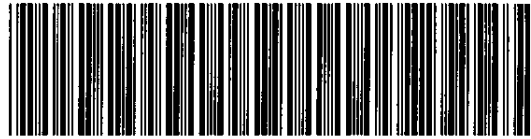

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Daily Bread Storehouse Ministries, Inc., and is a not for profit corporation.

**ARTICLE II**

The existence of the Corporation shall begin on August 15, 2007, and shall be of perpetual existence.

**ARTICLE III**
