DURATION:

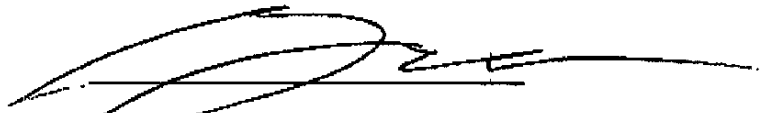

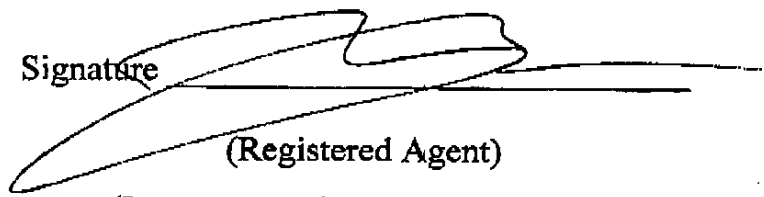
