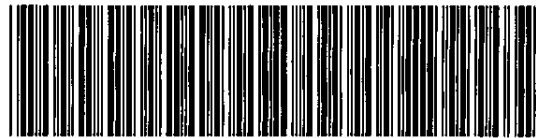

ARTICLE I

NAME

The name of this incorporation shall be: **CIVIL SERVANT PRODUCTIONS, INC.**

ARTICLE II

PURPOSE

The corporation will engage in any activity or business permitted under the laws of the United States of America and of this State.

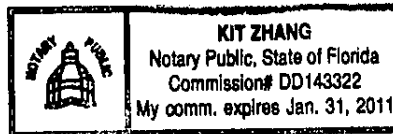
