

The undersigned, for the purpose of forming a for-profit Corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

**Article I**

**Name**

The name of this Corporation shall be HOPE Educational Consulting Services, Inc., (hereinafter called the "Corporation").

**Article II**

**Principal Office and Mailing Address**

The principal office and mailing address of the Corporation is 111 E. Tiffany Dr. Apt. #2, West Palm Beach, Florida 33407.

**Article III**

**Purpose**

The Corporation is a profit organization organized for the purpose of engaging in any lawful act or activity for which for-profit Corporation may be organized, so far as in or may be permitted by the laws of the State of Florida. The specific purpose of the Corporation is to develop Educational Development Programs. The Literacy Connection (T.L.C.), Professional Development, Notary Services, Writing and Editing Services (WES), Informational and Educational Brochure and Pamphlet Services, Career Development, Adult Literacy Enhancement Academic Program (A LEAP), Male Adolescent Program (MAP), Community Resource Counseling Services (CRCS), Family Educational Resource Program (FERP), Teen Adolescent Program (TAP), Mothers Mentoring Mothers (M&M's), Positive Outstanding Women Earning Respect (P.O.W.E.R), Tutoring, Curriculum Development, In-Services Training, Workshops, Seminars, Diagnostic Testing (DAR, BRI), Certified CPR & First Aid Instructor, etc.

**Article IV**

**Capitalization**

The aggregate number of shares that the Corporation is authorized to issue is 1,000.00. Such shares shall be a single class and shall be a par value of \$1.00 per share.
