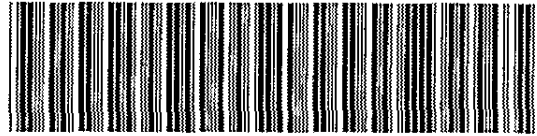

I, the undersigned subscriber to these Articles of Incorporation a natural person, competent to contract, of legal age, by these presents, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

NAME





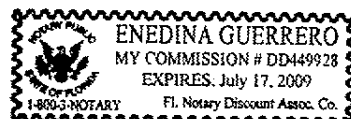
