

#### ARTICLES OF INCORPORATION

OF

# SUEGLE, INC.



#### ARTICLE 1. NAME

The name of the corporation is Suegle, Inc.

#### ARTICLE 2. ADDRESS OF CORPORATION

The address of the corporation is 304 S. Plant Avenue, Tampa, Florida 33606.

# ARTICLE 3. DURATION

This corporation shall exist perpetually.

#### ARTICLE 4. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business. Without limiting or restricting in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of Florida, the corporation shall have the following general powers:

To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated.

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets.

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of all its property, franchises, and income.

To lend money for its corporate purchases, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

To conduct its business, carry on its operations, and have offices and exercise the powers

granted by this act within or without this state. •

To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.

To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for the administration and regulation of the affairs of the corporation.

To transact any lawful business which the board of directors shall find will be in aid of governmental policy.

To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries.

To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust or other enterprise.

To have and exercise all powers necessary or convenient to effect its purposes.

To indemnify any person who was or is made a party, or is threatened to be made a party, to any proceeding by reason of his having served as a director, officer, employee or agent of the corporation all as provided by applicable law.

To purchase, take, receive or otherwise acquire, hold, own, pledge, grant a security interest in, transfer, or otherwise dispose of its own shares.

#### ARTICLE 5. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000,000 shares of common stock of one class only, having no par value.

#### ARTICLE 6. PREEMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of this corporation of the same

kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof at the price at which it is offered to others.

# ARTICLE 7. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this corporation is 304 S. Plant Avenue, Tampa, Florida 33606, and the name of the initial registered agent of this corporation at that address is Matthew D. Powell, P.A.

# ARTICLE 8. DIRECTORS

The corporation shall have 9 directors initially. The number of directors may be increased or decreased from time to time, in accordance with bylaws adopted by the shareholders, provided, that the corporation shall always have the minimum number of directors required by law.
