ARTICLE 1. NAME

The name of this corporation shall be INTEGREE U.S.A., Inc.

#### ARTICLE II - COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Secretary of State, Division of Corporations. This corporation's duration shall be perpetual.

#### ARTICLE III - PURPOSE

This corporation is being organized for the purpose of engaging in the import/export, sale and distribution of cosmetics, beauty products, dietary products and dietary supplements, drugs and medical products, and any related products and equipment, including appliances and accessories, fitness and physiotherapy machinery, plants, equipment, furnishings and relevant tools and appurtenances. The purpose includes, but not limited to:

To establish, maintain, and operate hotels, resorts, tourist facilities, beauty
farms, SPAs, wellness and fitness centers, of every kind and description,
incidental to, connected with, or suitable, necessary, or convenient for, any

- To organize or cause to be organized under the laws of any state of the United States, or of the District of Columbia, or of any territory, dependency, or possession of the United States, or of any foreign country, a corporation, limited liability company, partnership, joint venture (or combination thereof), for the purpose of transacting, promoting, or carrying on any or all of the objects or purposes for which this Corporation is organized, and to dissolve, wind up, liquidate, merge, or consolidate any such entities or to cause the same to be dissolved, wound up, liquidated, merged, or consolidated.
- To enter into any lawful arrangement for sharing profits, union of interest, reciprocal concession, or cooperation with any person, firm, association, or corporation in the carrying on of any business which this Corporation is authorized to carry on, or any business or transaction deemed necessary, convenient, or incidental to carrying out any of the purposes of this Corporation.

- To have one or more offices, conduct and carry on its business and operations, and otherwise to promote its objects within and without this state, in other states, the District of Columbia, the territories, and dependencies of the United States, and in foreign countries, without restriction as to place or amount, but subject to the laws of such state, district, territory, dependency, or country,
- and in general: management, distributorship, franchising, licensing, import/export, research and development, production and fabrication, agency, and engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.

#### ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 95 (ninety five) shares, each of one thousand dollars par value, of common capital stock ("Class A"), and 5 (five) shares, each of one thousand dollars par value, of preferred stock ("Class B"). The "Class B" preferred stock will give no right to capital distribution, but only preferred distribution of dividends in the fix ratio "Class B"/"(Class A" + Class B)" of 5/100, all other corporate stock features by operation of law remaining unchanged.
