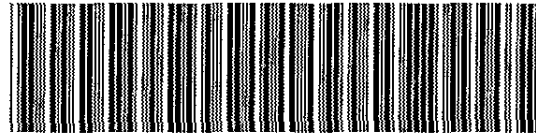

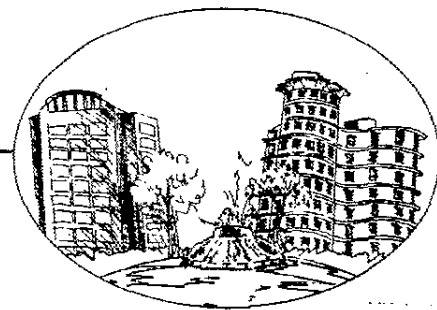

**ARTICLES OF INCORPORATION
OF
C & J Event Coordinating, Inc.**

ARTICLE I

Name. The name of this corporation is C & J Event Coordinating, Inc.

ARTICLE II

Indemnification. The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

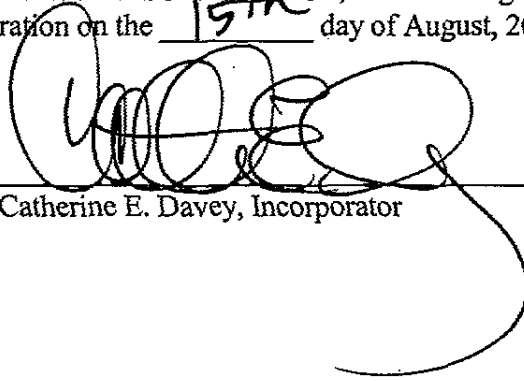
ARTICLE X
