ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Florida Vegetation Control, Inc.

ARTICLE II

The existence of the corporation shall begin on August 17, 2007.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 2774 Ryan Boulevard, Punta Gorda, Florida 33950.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 5000, all of which shall be Common Shares.
