ARTICLES OF INCORPORATION FOR



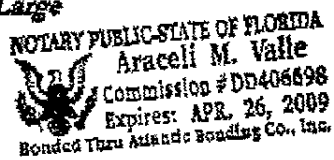
