#### Article I

#### NAME

#### Article II

#### DURATION

The Corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of State.

#### Article III

#### **NATURE OF BUSINESS**

The Corporation may engage in any activity or business permitted under the laws of The United States of America and the laws of The State of Florida: the teaching of the arts, and provide general art education to children, thereby enhancing such skills as:self-esteem, motivation, creativity, improved emotional expression and the promotion of the arts.

#### Article IV

#### CAPITAL STOCK

- Authorized Capital. The maximum number of shares of stock which this Corporation, is authorized to have outstanding at any one time is ONE THOUSAND (1,000) shares of stock with one dollar (1,00) par value. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.
- 2. Preemptive Rights: Shareholders shall have no preemptive rights.
- 3. Cumulative voting: Cumulative voting shall not be permitted.
