Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, XYZ SPEECH & LANGUAGE THERAPY, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is XYZ SPEECH & LANGUAGE THERAPY, INC., (hereinafter called the "Corporation").
2. Article I of the Corporation's Articles of Incorporation is deleted in its entirety and replaced with the following new Article I:
